10. New Business

- 10.1. Chief Gaudet presented the Board of Directors with a report outlining all options for tax increases for April 2022. A very long discussion ensued, and an official copy of the report is attached to the official minutes. Director Brown made the motion to approve the plan that includes the following:
 - Remove a new firehouse as part of this tax increase
 - Lower the amount we are asking for to \$0.3500 to retain the 6 full time firefighters on the safer grant.
 - See if we could implement the tax increase in phases (\$0.25 year one, \$0.05 year two, \$0.05 year 3).

The motion carried without objection.

- 10.2. Chief Gaudet told the Board that our riding mower was damaged and required \$1,100.00 work of repairs to the deck. The blade bearings were out along with some pullies and belts. Chief Gaudet stated the mower was bought in 2009. Chief Gaudet had obtained 3 quotes to purchase a new 52–54-inch zero turn, mower and they are as follows:
 - Lawn Care Equipment Company Gravely ZTX 52-inch deck \$3,395.62
 - Caldwell Lawn Equipment Hustler Raptor XD 54-inch deck \$4,249.00
 - Lowes Ariens Ikon XD 52-inch Deck \$3,499.00

Chief Gaudet asked the Board if they wanted him to have our current riding mower fixed for \$1,100.00 or purchase a new mower. After a discussion, Director Brown made a motion to purchase the Gravely ZTX from Lawn Care Equipment Company for \$3,395.62 from the Equipment and Apparatus Fund, and trade in the old broken mower as part of the transaction. The motion carried without objection.
