1 Meeting Opening

1.1 Call to Order

Decision: The Incoming Board of Directors meeting of the Hillsboro Fire Protection District was called to order on March 10th, 2021 at 7:10PM, at Hillsboro Fire Protection District Station 1, in the Boardroom, Located at 120 5th Street, Hillsboro, MO 63050. Present were Gary Boyer, Matt Woods and Robert Brown. Fire Chief Brian Gaudet and Deputy Chief Jason Darain were also present. Director Gary Boyer will "Chair" the meeting and he announced that a quorum was present. Fire Chief Brian Gaudet recorded the minutes.

2 Special Orders of the Day

2.1 Director's Oath of Office

Robert D. Brown and Gary W. Boyer took and signed their oath of office for filing with the Jefferson County Clerk's Offices.

2.2 Board of Directors Reorganization

Decision: Director Gary Boyer stated there was an election. Robert Brown was elected to finish a 4 year unexpired term and Gary Boyer was elected to a 6 year term.

> Director Boyer stated with the newly elected Board Members; the Board must elect the Officer Positions for the Board Members. Director Woods made a motion that Director Boyer maintains the Board President position, Director Boyer made a motion that Director Woods maintains the Treasurer's Position and that Director Brown becomes the Secretary. All Directors were in favor of the two motions on the floor and a roll call vote was taken:

The motion carried without objection.

Director Boyer made a motion to continue to have Brian Gaudet record the minutes on behalf of the Secretary of the Board of Directors. All were in favor and the motion carried without objection.

5 Fire Chief's Report

5.1 Previous Month's Alarm Report

5.3 Tax Increase

Chief Gaudet and the Board discussed the recent tax increase failure. After a long discussion the Directors were in agreement that we should try again in April of 2022 and drop from a \$0.50 tax increase to a \$0.25 tax increase. We will scrap the plans for a new firehouse and attempt to retain the 6 AFG SAFER employees on a permanent basis.

7 Old Business

7.1 Heavy Rescue Trailer Update/Graphics Purchase

Chief Gaudet asked the Board of Directors to spend \$1,500.00 out of the previous \$10,000.00 approved to wrap the Heavy Rescue Trailer. The work will be completed by Vinyl Images out of Fenton MO. All of the Directors were in favor and stated the money has already been approved.

7.2 Shared Apparatus Agreement Update

Chief Gaudet gave an update on the agreement with the spare apparatus. There has been some issues that has arisen with ISO and Desoto Rural. ISO requires a spare engine for every 8 in service engine companies. With Hillsboro, Mapaville and Desoto Rural sharing the apparatus that would put us way over and require 2 reserve engines. So Desoto Rural may be out of the agreement, but Chief Gaudet spoke with Chief Brown at Mapaville and both entities are still in favor of sharing the apparatus. The Board members were still in favor of pursuing the shared apparatus agreement even if Desoto Rural cannot participate.

8 New Business

8.1 Comprehensive Insurance Renewal

Decision: Chief Gaudet presented the Board with the May 1st 2021
Comprehensive Insurance Renewal quote from Custom Insurance.
The policy is underwritten by Continental Western/Fire Pak. The cost for the period of 5/1/2021 - 5/1/2020 is \$22,931.00. Chief Gaudet stated we were underinsured on contents at 1 house, 2 house and the loose equipment on the apparatus. All of those numbers were upped. Director Gary Boyer made a motion to renew the insurance policy as presented. The motion carried without objection.

8.2 Employee Medical Insurance Renewal

Decision: Chief Gaudet presented the Board with the Medical Insurance Renewal for the period of 6/1/2021 to 6/1/2022. The plan is through Anthem and part of the Missouri Federation of Chamber of Commerces groups. We will see a 7.1% increase in premiums this coming period, which is good. Director Woods made a motion to renew the policy as presented. The motion carried without objection.

8.3 Director Brown to the District Bank Accounts

Decision: Chief Gaudet stated the Bank Account Signature Cards need to be updated since we have had an election. Director Boyer made a motion to remove Marcy Wokurka from the District Accounts and add Robert D. Brown to the District Bank Accounts. The motion carried without objection.
