July 14, 2021

#### 1. Meeting Opening/Announcement of a Quorum

1.1. The Regular Monthly Board of Directors meeting of the Hillsboro Fire Protection District was called to order on July 14th, 2021, at 7:00PM, at Hillsboro Fire Protection District Station 1, in the Boardroom, Located at 120 5th Street, Hillsboro, MO 63050. # 7. Fire Chief's Report

- 7.1. Chief Gaudet presented the Board with the written Chiefs report
- 7.2. It was yet again a record-breaking month. The Hillsboro Fire Protection District ran 119 calls for service in June of 2021. This is most calls ever run in a month by the Hillsboro Fire Protection District. The run of bad calls continues for our residents. On June 10<sup>th</sup> we suffered a fire fatality from a vehicle accident on Highway BB.

#### 8. Communications

8.1. Chief Gaudet present the Board with the First Certification of the 2021 Assessed Valuation. Chief Gaudet stated our assessed valuation has increased by a substantial amount, approximately 20 million dollars. However we won't see that amount for we will only be able to increase our budget by the CPI adjustment, which is 1.9% and new construction. We will have roll back our tax rate several cents to comply with the Handcock Amendment.

10.1. Chief Gaudet presented the Board of Directors with the received concrete driveway replacement bids.

Only one contractor submitted a bid for the project, Kimes Contracting LLC. Kimes Contracting submitted the following bids:

- Primary Project (Driveway in front of Engine Bay Replacement -\$11,880.00
- Alternative Bid 1, Parking lot replacement \$31,555.00

After some discussion, Director Woods made a motion to accept Kimes Contract LLC's bid for the Primary Project only in the amount of \$11,880.00. All were in favor and the motion carried without objection.

10.2. Chief Gaudet presented the Board of Directors with an update to Board Management Policy 4 (BMP 4) titled Banking Policy. Chief Gaudet stated he would like to start paying all of the district's bills online. Chief Gaudet stated that all invoices would be signed and reviewed by at least 2 Directors prior to submission through the bank. It would be the same two signature system we use now, but the Directors would sign the invoices not the Checks. This will save on postage, envelopes, and time. Director Brown made a motion to accept the update to BMP 4 and begin paying as many of the District's bills as possible online. All were in favor and the motion carried without object.
